FIVE STEPS TO ORGANIC CERTIFICATION

QAI will assign a dedicated project manager to guide you and answer questions through each step of certification.

APPLICATION

- Submit the completed application form and supporting documentation. Let us know if you need other certifications such as gluten-free or non-GMO.
- We will assign you a dedicated certification project manager.

INSPECTION

- QAI verifies information on the application.
- On-site inspection confirms practices are consistent with organic regulations.
- When you are certified, annual on-site inspections will continue to be required.

REVIEW

- Technical reviewer evaluates the inspection report
- If any deviations or inconsistencies are noted, non-compliances are issued.

RESOLUTION

• QAI will notify you of non-compliances and you will have the opportunity to provide a timely resolution.

CERTIFICATION

• After successfully completing your inspection and technical review, you will receive an official, numbered certificate and will be able to use the organic mark!
